\* Definition of Family:

The definition of 'Family' as used in Club Membership consists of the member and spouse, unmarried children under 21 years old living at home or dependent children under 24 away from home attending school or in the armed forces. Children 18 and over and married are not eligible. When son or daughter reaches 24 they are not included in your membership under any circumstances. Individual consideration may be given for unique family situations upon request of the member. Final decision will rest with the Club Management.
